All Submissions are required to be submitted by immediate family members of BRPOA members in good standings as of the date postmarked on the submission envelope validation through USPS, FedEx, UPS, Airborne, DHL (or other registered national mail carrier service). Submissions must include this form, filled out completely and original. No copies, photocopies or facsimiles will be accepted. Failure to meet all of the listed and stated requirements will result in disqualification. Winner will be notified on 06/01/08 via telephone. Winner will receive recognition on the Official BRS website, in the Shoreline and be awarded a commemorative T-shirt.

## Rules & Regulations of Contest

1. Submissions become the property of Blue Ridge Shore and the CSC, and will not be returned.
2. BRS and the CSC reserve the right to modify the artwork to fit into a format for graphic printing.
3. Entrants must be members or immediate family of members in good standing as of the date of the postmarked entry. Immediate family includes members, husband, wife, legal dependant(s) under the age of 21, significant life partners in co-habitation and those specific dependants under the age of 18.

4. Entries will be voted on by the Independence Day Committee Chairperson, 2 IDC event coordinators as assigned by the chair, and 2 members of the BRS Board of Directors selected by the BOD.
5. Entry Process –
  - All entries must include a submission form signed by artist and legal guardian of under 18.
  - All entries must be postmarked by 05/24/08 and received to the correct address by 05/27/07.
  - All entries must have the following written on the envelope **“Event-Logo art Contest :07/05/08”**.
  - All entries must be sent via registered, national mail service (such as USPS, FedEx, UPS, DHL, Airborne...).
  - No Hand Carried, Hand Delivered, un-marked date stamped submissions will be accepted.
  - No entry will be accepted without envelopes or completed and signed submission forms.
6. Voting process -
  - Meets all rules and requirements
  - 3 rounds of voting, if necessary (all votes to be recorded)
    - Round 1 – narrow to selection of 5 each judge getting 1 vote
    - Round 2 – narrow to 3 each judge gets 1 vote
    - Round 3 – 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> ranking each judge gets 1 ranking
  - Winner will be announced via phone and published on (the official BRS Website)
7. All rules and regulations must be adhered to as stated above.
